SPECIAL CITY COUNCIL MEETING
ZOOM AUDIO WEB CONFERENCE
108 W. 4th STREET
April 2, 2020

At 6:05 P.M. Mayor McDonald called the meeting to order via Zoom.us.

Agenda item 2 was roll call. Those present were Council Members Cohrs, Sporrer, Moss and Scheuring and Mayor McDonald. Council Member Fisher connected to the meeting at 6:07 P.M.

Agenda item 3 was to approve the agenda. Motion was made by Cohrs and seconded by Scheuring to approve the agenda. 4 ayes.

Agenda item 4 was to approve the consent agenda which consisted of approving building permits for John Johnsen, 415 E. 2nd St., demolition permit; Becky Busing, 117 S. 4th Ave., finish basement. Motion was made by Moss and seconded by Fisher to approve the consent agenda. 5 ayes.

Agenda item 5 was to discuss processes and procedures dealing with Covid-19. Mayor McDonald gave an update on the donations for vouchers for food that are being given away through Logan Super Foods. To date, this program has been utilized by several people. He also discussed the newsletter that was sent out by the City with information that pertains to the Covid-19 crisis. He doesn't feel that it is necessary to send another one at this time.

Agenda item 6 was to discuss the burning of yard waste ordinance and consider suspending burning until further notice. There have been complaints about the burning from a citizen or citizens that have compromised respiratory issues. At this time burning is allowed only on Saturdays, but citizens are burning on other days. Doctors are recommending that we have a burn ban because of the respiratory issues. The City of Logan used to have a dumpsite, but the DNR shut it down because people were dumping items other than yard waste and using it as a landfill. Motion was made by Scheuring and seconded by Cohrs to suspend burning until the end of May and open up an area by the Capital Building for people to dump yard waste from 8:00 A.M. to 4:00 P.M. Monday through Friday. 5 ayes.

Agenda item 7 was to review the Senior Citizen Meal Program and discuss continued service. Evelyn Bucy is the only person that is in the kitchen or senior center while she is preparing the meals and cleaning up. After the meals are prepared, they are delivered to each person curbside by Angela or Marilyn, who wear face masks and gloves. The main concern that Evelyn has about continuing this program is getting food from the grocery store, and that issue has been resolved. The Council was in favor of keeping the program going, and they will discuss it at a later time if needed.

Agenda item 8 was to discuss possible changes to work schedules for city employees due to Covid-19. During this crisis, we are trying to limit our exposure to other people and each other. One concern is that there are only two employees in the office and what would happen if both of them would get sick at the same time. Clerk Winther is getting a laptop set up so that she can work from home. The consensus of the council was for the employees

to figure out what works best for social distancing, and this subject can be revisited if needed.

Agenda item 9 was the Clerk's report.

Agenda item 10 was citizen's questions/comments. There were none.

Agenda item 11 was to adjourn. Motion was made by Cohrs and seconded by Moss to adjourn. 5 ayes.
