CITY OF LOGAN CITY COUNCIL MEETING CITY HALL 108 W. 4TH STREET April 6, 2015

At 7:00 P.M. Mayor Foutch called the meeting to order.

Agenda item 2 was Pledge of Allegiance.

Agenda item 3 was roll call. Those present were Council Members Cohrs and DeWitt and Mayor Foutch. Council Member Sporrer arrived at 7:03 P.M.

Agenda item 4 was to approve the agenda. Motion was made by DeWitt and seconded by Cohrs to approve the agenda. 2 ayes.

Agenda item 5 was to approve the consent agenda which consisted of approving the minutes of the 3/23/15 regular City Council meeting, set a date of April 20, 2015 for the next regular city council meeting, approve the claims register, Treasurer's report and revenue report and building permits for Doug Johnsen, demolition of 320 N. 5th Ave; Harrison County Humane Society, 106 N. 5th Ave., remodel improvements inside building. Motion was made by Cohrs and seconded by DeWitt to approve the consent agenda. 2 ayes.

Agenda item 6 was to approve a request from Timerz Pub & Eatery to close 4th Avenue from 7th Street to the alley and part of the alley for a benefit on May 16th. They plan to have a band and will be closing 4th Ave. and the alley behind the business. Motion was made by DeWitt and seconded by Cohrs to approve a request from Timerz Pub & Eatery to close 4th Avenue from 7th Street to the alley and part of the alley behind the business for a benefit on May 16th from 8:00 P.M. until midnight. 3 ayes.

Agenda item 7 was to approve the second reading of Ordinance 445: An ordinance to amend chapter 69.03, Angle Parking and Parking Regulations. This would change the parking from angle to parallel on the north side of 7th Street (Highway 30) from Maple Avenue to 5th Avenue. Motion was made by Cohrs and seconded by Sporrer to approve the second reading of Ordinance 445: An ordinance to amend chapter 60.03, Angle Parking and Parking Regulations. 3 ayes.

Agenda item 8 was to approve having Iowa Codification Inc. update or supplement the Logan Code of Ordinances. The City Code was originally adopted in 2000. Iowa Codification provided two options for the City. Option 1 is to bring the current Code up to date for \$475.00, plus the cost to add legislative updates for the last four years. Because of the age of the Code and necessary updates, they recommended Option 2, which would provide completely new code books to bring them in line with City and State Regulations. It would include the supplementation of any uncodified ordinances and also give a comprehensive update of our existing City code book to incorporate State legislative changes and City requested updates. The cost of Option 2 would be approximately \$5800.00, which would be spread out over more than one fiscal year as the process will take at least one year to complete. Motion was made by Cohrs and seconded by DeWitt to redo the Logan Code of Ordinances at a cost of \$5800.00. 3 ayes.

Agenda item 9 was to discuss and approve a request from Chief Brensel for wage increases for police officers working the night shift. In an attempt to retain officers, Chief Brensel requested a \$2.00 per hour increase upon completion of the academy. This rate would go from \$16.00 per hour to \$18.00 per hour for certified night shift officers. In the present budget, this money will come from the money that is saved by not having a third officer for the next few months. In future budgets, Chief Brensel feels that his training budget will be reduced because of officer retention. The Council discussed the reasons so many officers leave soon after being certified. Chief Brensel stated he believed that not offering family insurance, like so many other cities in the area, was a big factor. The cost to offer family insurance to all city employees would be far greater than a \$2.00 raise. Motion was made by DeWitt and seconded by Cohrs to approve Chief Brensel's request for a wage increase for certified police officers from \$16.00 per hour to \$18.00 per hour. 3 ayes.

Agenda item 10 was the Clerk's report.

Agenda item 11 was Mayor comments. There were none.

Agenda item 12 was citizens questions/comments. Mary Darling reported that a letter had been received by the Chamber of Commerce from the Carnival that has been in Logan on the 4th of July for many years. They informed the Chamber that they will not be in Logan this year for the 4th of July celebration.
